Third Update on Officer Involved Shooting from 12/9/13 involving Kelvion Walker

Over the weekend, detectives developed information regarding the identity of the driver of the carjacked vehicle taken at gunpoint that subject Walker was a passenger in at the time of the officer involved shooting. Those efforts led to the execution of an Evidentiary Search Warrant in the 9600 block of Jennie Lee Lane on December 16, 2013 by Dallas SWAT, Robbery and SIU detectives. Multiple individuals at the location were brought to Police Headquarters for interviews. Items believed to be stolen property were also recovered at the location. In addition, a stolen vehicle was observed at the location and two 15 year old juvenile suspects were arrested for Unauthorized Use of a Vehicle and Evading Arrest. Two additional suspects that were in the stolen vehicle remain at large.

Subsequent investigative actions linked one of the individuals at the house on Jennie Lee to the Aggravated Robbery of a vehicle that occurred at gunpoint at 9710 Military Parkway, on December 8, 2013. This suspect has been identified as Reginald Robertson B/M/12-1-94. Suspect Robertson has admitted to his role in this offense. The vehicle taken in this robbery was recovered at the same location where subject Walker was first observed entering the carjacked vehicle he was a passenger in at the time of the shooting.

Suspect Robertson has also admitted to detectives that he was the driver of the carjacked vehicle being pursued by Officer Wilburn on December 9, 2013. Robertson has been charged with Aggravated Robbery at gunpoint for the offense that occurred on December 8, 2013 and charges of Unauthorized Use of a Vehicle and Evading Arrest are pending for his actions on December 9, 2013 that resulted in the officer involved shooting. His and subject Walker's involvement in the Aggravated Robbery on December 9th remains under investigation. Suspect Robertson is currently in Lew Sterrett with a \$150,000 bond.

Interviews conducted overnight developed additional leads in the series of violent offenses in the Scyene/St. Augustine community since early December. Detectives are also reviewing the stolen property recovered during the search warrant to determine its relationship to these incidents or other offenses.

SIU detectives have been in contact with Subject Walker's attorney in an effort to schedule an interview, but have not been permitted access to interview him as of this time.

Update on Officer Involved Shooting from 12/9/13

On December 9, 2013, at about 3:05 p.m. Dallas Officers Amy Wilburn, #8111, Jason Correa #9314 and Matthew Terry #8915 responded to a motor vehicle taken in an Aggravated Robbery. The victim reported multiple suspects approached him at gunpoint and he was shot at twice as he ran from his vehicle at 9500 Bruton Road (Case Number 311447A). The complainant had recently purchased the vehicle. Officer Correa made contact with the lien holder, who then informed him of its location based on GPS data at 9500 Military Parkway. Covert officers responded to the area and located the vehicle and maintained surveillance. Shortly thereafter, covert officers observed two males enter the vehicle and begin driving away. They radioed for uniform officers to make a traffic stop.

Officers Wilburn and Correa, who were in full uniform and in marked squad cars, were nearby and observed the carjacked vehicle driving south on St. Augustine Road from Military Parkway. Officer Wilburn activated her red lights in order to conduct a felony traffic stop. The suspect vehicle increased speed and turned right into the St. Augustine Town Homes and continued west bound in the complex. The driver of the suspect vehicle slowed, opened the driver's side door, exited and began running as officers gave loud verbal commands to stop. This unknown suspect was not apprehended. The carjacked vehicle was left in gear and continued to move forward. Officer Wilburn approached to stop its progression unaware that Kelvion Walker B/M/19 was in the front passenger seat. Officer Wilburn perceived Walker to be an imminent threat drew her weapon and discharged it once striking him.

An independent civilian witness observed the shooting and was brought to Police Headquarters to provide a statement. The witness reported Walker was reclined in the front passenger seat and appeared to be holding both hands up at the time of the shooting.

DPD is reviewing in-car dash-cam video of the incident. Efforts are on-going to enhance the video to assist in the investigation. No weapon was located at the scene.

Subject Walker was transported to an area hospital where he remains in critical condition at last report. He has not been charged with a criminal offense at this time.

Officer Wilburn has been placed on Administrative Leave. She is a twelve year veteran of the Department assigned to the Southeast Patrol Division.
